1. NO PURCHASE NECESSARY TO WIN.

2. HOW TO ENTER: Fans must submit a short video to YouTube under the title “Atlantic Sun Basketball Fanatic.” The top videos will be selected by the conference office.

3. WINNERS: Of the top videos selected by the office, fans will vote on the fan submissions from February 14th to Feb. 17th at 2 p.m. ET. One (1) Grand Prize Winner will be selected on February 17, 2012. The odds of winning depend upon the number of entries received. The Contest is subject to all applicable NCAA, federal, state and local laws and regulations.
